AFP14/2023 Allotments Report

A verbal report was received from Councillor R. Bullock: -

- a) Fencing requirements at Dovecote Road to secure existing fencing to residential properties. Noted three inspections carried out by contractors. No quotations received to date. Refer to full Council as work urgent.
- b) Some plots require urgent attention
- c) Outstanding rentals noted. Advisory letters to be sent to tenants.
- d) Application for change of name to tenancy noted.
- e) Recommendation for rentals to commence from 1st January each year to allow time to re-let unused gardens before growing season commences. Letters could then be issued each January to tenants not maintaining plots within the terms and conditions of the tenancy agreement.
- f) Recommendation try for one year to request rental from 1st January 2023 for 9 months rental.
- g) Tree to be inspected by tree surgeon on 29th June 2022 Derby Road allotment site following complaint.
