#### TC080321/4 Declarations of Members Interests

Cllrs S Bagshaw, D Bagshaw and K. Woodhead declared personal interests in all matters relating to allotments, as allotment holders.

Cllrs S Bagshaw and D Bagshaw declared an interest in Minute Number TC080321/12, due to involvement in Eastwood Volunteer Bureau and Citizens Advice Bureau and withdrew from the Meeting during discussion and deliberation of this matter.

#### TC080321/5 Public Speaking

Cllr D. Bagshaw gave an update on crime statistics for the local area.

Cllr Harper apologised for not attending the last Meeting. He provided an update on all County matters including potholes, streetlights, gullies and highways issues. He was also asked to look into manholes which appeared to be collapsing outside the Derby Road allotments and on Mansfield Road adjacent to the Park. Councillor Radulovic (Broxtowe Borough Council (BBC)) gave an update on the £25 million worth of business support grants and business rates holidays that had been allocated in Broxtowe. In addition, business restart loans would be available shortly. BBC were also now prioritising work on a post-COVID recovery plan. BBC were the 5<sup>th</sup> most effective authority in the country at issuing COVID related loans, and Nottinghamshire were the highest.

#### TC080321/15 Levelling-Up Agenda Bid for Eastwood

An update was provided on the Levelling-Up Agenda bid and Consultation Response. It was reported that so far, 1078 responses had been received and recorded. There were 974 responses in favour, 66 not in favour and 38 don't know/abstain/spoiled papers. It was agreed that the response rate was incredibly high. Cllr Radulovic reported that the project proposal had to be submitted by September 2021. A report would be submitted to Committee shortly at Broxtowe Borough Council who would allocate resources to ensure a comprehensive bid could be submitted. An Oversight Board would also be set up which would comprise of; Member of Parliament

- 1 Nottinghamshire County Council representative
- 2 Broxtowe Borough Council representatives
- 2 Eastwood Town Council representatives
- 1 Private Sector representative
- 1 Volunteer Sector representative
- 1 Health CCG representative
- 1 Shop/Business representative

Other projects were also discussed including the Durban House Health and Wellbeing project which would go ahead, being funded by s106 contributions, the DH Lawrence environmental project, and the post-COVID recovery economic strategy.

#### TC080321/16 Electricity Contract

It was agreed to delegate negotiation of the electricity/gas contract to the Clerk in consultation with the Leader of the Council (Minute Number TC080221/12), and it was reported that the contract had been awarded to Octopus.

#### TC080321/17 Insurance

The Council's insurance was due for renewal on 1.4.21. Quotations had been requested. **RESOLVED** as three quotations hadn't been received in time for the Meeting, to delegate negotiation of this contract to the Clerk, Deputy Clerk and Leader of the Council.

#### TC080321/18 Training

This item was not considered.

#### TC080321/19 Fencing – Derby Road Allotments (Cllr K. Woodhead)

At the recent Council Meeting, it was agreed that ClIrs D. Bagshaw, Woodhead and the Clerk acquire quotations for fencing to secure the fence-line at the Derby Road. A price had been received for a 1.8m high 50 x 2.5mm 25m roll of galvanise chain link fencing (inc line wire) - £203.23 inc VAT. ClIr Woodhead offered to arrange for the work to be completed. The Clerk requested that this was not started until a risk assessment had been completed.

RESOLVED that CIIr Woodhead arrange for this work to be completed at a cost not exceeding £200.00, once a risk assessment had been completed.

#### TC080321/20 Town Twinning (Virtual)

It was suggested that Eastwood Town Council might want to consider resurrecting their town-twinning link with Szolnok in Hungary, which could be carried out virtually. In addition, papers had been circulated with details of a musical project that was planned to take place with Broxtowe Borough Council's twin city Gutersloh (Germany). Councillors spoke of their support for these ideas.

#### TC080321/21 Engagement (Cllr D. Bagshaw)

Councillors had been asked to submit their ideas on engagement with local residents/suggestions of small projects that they might wish to pursue etc. One response had been submitted. **RESOLVED that an A & E Committee Meeting be arranged to discuss ideas further.**
