ETC153/2023 Public Participation

- i. <u>Police Matters</u> P.C.S.O. Davies addressed the meeting with information relating to local issues including updates for the area; no particular spikes in crime related matters. Off-road Police cycles were to be used more as weather improves. Questions dealt with included damage to trees at Hall Park, anti-social activities around Eastwood bowling green, electric scooters used around the park. P. C. S. O. Davies reported school visits were planned to discuss with students the legalities of riding scooters; noted drug issues reported around Albert Street. Noted recent bad press for Police had not generated adverse effects for the Eastwood area. The Mayor, on behalf of the Town Council, extended appreciation to P.C.S.O. Davies for his attendance; the Officer remained at the meeting.
- ii. <u>Address by members of the public</u> (I) Report of fly tipping at Princes Street. Cllr Radulovic agreed to report the matter to the authorities. Fly tipping recently reported had been removed by Broxtowe Borough Council. (II) Upgrading of cameras at Coronation Park and Princes Street noted consultation in the public domain; members of the

public encouraged to participate. The Mayor, on behalf of the Town Council, extended appreciation to the Borough Council for carrying out clearing to the area. (III) Reverend Stevenson requested an update on the situation with reference to the disappointing news the Levelling Up bid was declined.

iii. Nottinghamshire County Council Matters

- Nottinghamshire County Councillor K. Oliver addressed the meeting with a report on the following matters:-
- County Council Budget 2023 2024 information
- Roadworks Queens Road South reported as concrete road, priority works required with the matter under review; Raglan Street and Nottingham Road at corner of Newthorpe Common reported as in poor condition; Cllr Oliver reported on situation.
- Divisional funds reduced.
- Tinsley Bridge safety improvements: Cllr Oliver to pursue date for completion of works before end of financial year 2022 2023.
- Consultation on Ambleside Drive, Coppice Drive and Fern Crescent for TRA installing permanent parking.
- Fly tipping Princes Street noted.
- Trees requiring attention outside Iceland noted. Some within private curtilage.
- Pavements Victoria Street and Albert Street report for attention. Three-year programme for works to be checked.
- Walker Street requiring attention, busy road with many families and children using the access to school.
- Christmas lighting 2023 requirements for anchor points to premises on Nottingham Road; Cllr R. Bullock updated Council on meeting with lighting contractor with a report due by 31st March 2023.
- Lighting columns noted two had been replaced but no electrical socket for festive lighting connections.
