Allotment Report 08.06.2023

Allotment tenancies

Several plots at Dovecote Road have been let to new tenants this year the majority women and there are now quite a lot of tenants who take their children with them to the allotments. There are now only two plots vacant at Dovecote Road both of which are in a very neglected state and I think and another two at Derby Road.

There are a few plots which are not being used sufficiently and this will be monitored and warning letters issued as required.

Allotment rent

The rental period was changed from the financial year to the calendar year to make the rental period consistent with the growing season which helps when new tenants take on a plot as they are able to cultivate the plot in their first year.

There are a few tenants who are late paying and have to be chased for payment. This is a waste of the Financial Assistants time and is a cost to the council both in staff time and lost rent. I would like to introduce a late payment fee for those tenants.

The rent has at £20 per 1/2 plot and £40 per Full plot not been increased for at least 5 years and I believe it should be reviewed especially if the provision of skips is continued.

Allotment Rules Review

There should be a full review of the allotment rules and where necessary changed to ensure they comply with the 'Law of Allotments'.

Composting Toilet

There are a lot of families using the allotments and I would like the council to consider installing a composting toilet at each site. I believe grant funding may be available and I would like to arrange a visit to the allotments at Underwood where a composting toilet was installed a few years ago.
